"AS IS WHERE IS BASIS" LYING WITHIN THE FACTORY PREMISES  
AT 14, MAYURBHANJ ROAD, KOLKATA – 23.**

The scrap consists of defective equipments, broken furniture, M.S. beams, angles, channels of old factory shed, PVC insulated copper cables, porcelain bushing with aluminum stud, M.S. corrugated sheet, M.S. enclosures, old M.S. factory gate, M.S. structures fitted with wire mesh, current transformers, M.S. pipes, water tank, slotted angle rack, steel window etc.

Scrap can broadly be classified into the following categories -

- a) M.S Light section material
- b) M.S. Heavy section material
- c) Aluminum items
- d) Copper items
- e) Brass items
- f) PVC insulated Copper Cables

Bidders are required to quote their highest rates in Rs/Kg. for each category separately. Rates should be quoted on the basis of lifting the material from the factory premises. Bidders are to submit payment on the basis of actual weight of material collected in each category at the above quoted rates.

Contractors are requested for physical inspection of the scrap material before submission of offer. The scrap can be seen from Monday to Friday between 2pm to 4pm up to 18/11/2012.

## **GENERAL TERMS AND CONDITIONS**

**1. Submission of offer** - The offer has to be submitted in two parts

(A) **TECHNO-COMMERCIAL BID** along with EMD in a SEPARATE ENVELOPE superscribing "Techno-Commercial Bid for Sale of Scrap".

(B) **PRICE BID** in a SEPARATE ENVELOPE superscribing "Price Bid for Sale of Scrap".

Both the Techno-Commercial Bid and Price Bid should be put in to ANOTHER ENVELOPE and sealed. **Tender No.** should be clearly mentioned on each of the sealed envelopes.

**2. EMD:** Rs. 20,000/- (Rupees Twenty Thousand only) by way of **Pay Order / Demand Draft** drawn in favour of M/S ANDREW YULE & CO.LTD payable at Kolkata. Bidders who are SSI/MSME units may apply for exemption from furnishing EMD by making a specific request in writing and enclosing the necessary document in support of the same.

If reason for non-submission of EMD or adjustment against the outstanding balance for EMD is not mentioned in Techno-commercial bid of tender, the tender will be rejected.

OFFERS WITHOUT EMD / ADEQUATE REASON FOR NON-SUBMISSION SHALL BE REJECTED

**3. Execution** - The scrap is to be collected within **4 – 6 weeks** from the date of receipt of order. Please confirm acceptance.

**4. Security Deposit** - The EMD amount of the successful Bidder will be retained as security deposit towards execution of the order and the same will be released after successful execution of the order. For unsatisfactory performance and / or contractual failure, the security deposit shall be forfeited. Please confirm acceptance.

5. **Risk purchase clause** - The company reserves the right to impose risk purchase clause for delay in execution by the successful bidder and shall have every right to do the same through some other agency/s which shall be deemed fit and the difference in revenue earned shall be recovered from the successful bidder. Please confirm acceptance.
6. **Liquidated damage** - If the execution is delayed beyond the scheduled date as specified in the purchase order, penalty will be levied @ 1/2% per week subject to a maximum of 5%. Please confirm acceptance.
7. **Arbitration** - All disputes relating to this order or otherwise arising thereof between the seller and buyer shall be subject to and referred to the Court or Competent Jurisdiction situated within the limits of the City of Kolkata. Please confirm acceptance.
8. **Payment Terms** - Successful bidder must make 100% payment including taxes and duties in the form of demand draft / pay order drawn on any nationalized bank before taking delivery of material. Please confirm acceptance.
9. **Validity of offer** - Your offer should remain valid for acceptance for a minimum period of 60 days from the date of tender opening. Offers sent through email or fax will not be considered. Please confirm acceptance.
10. **Separation of scrap** - Successful bidder has to make their own arrangement (manual labour, crane, gas cutter etc.) for separating different category of scrap items. Please confirm acceptance.
11. **Taxes and duties** - As applicable at the time of removal of material. Please confirm acceptance.
