**General Information:** The **four** Dooars gardens of Andrew Yule viz: Banarhat, Karballa, New Dooars & Choonabhutti Tea Estates have undertaken the job of uprooting shade trees & tea bushes for this year totaling approximately 61 Hectares. Separate tender has already been published for uprooting operation.

This tender invites commercial selling of the uprooted shade trees (950 nos. in total approximately) to the highest bidder after obtaining necessary permission for the four gardens viz. Banarhat, Karballa, New Dooars & Choonabhutti Tea Estates. The job may be split between more than one party. Management reserves the right to accept or reject any Tender without assigning any reason whatsoever.

Application should be made under sealed cover superscribed with the words: "Application for Sale of Shade Trees" to the Manager, Karballa Tea Estate., P.O. Banarhat,, Dist. Jalpaiguri.

#### **Scope of Work:**

- 1. All permissions from the Forest Department & other Government agencies as necessary for commercial selling shall be obtained by the party through his own arrangement & at his own cost. Necessary N.O.C. from relevant authorities as per the rules if required needs to be obtained by the party.**
- 2. Necessary Transit Pass for carrying the timber from the garden will be obtained by the party.**
- 3. West Bengal VAT as applicable on the sale value will be charged extra & to be borne by the party.**
- 4. Measurement of logs will be done in the presence of garden representatives as per the standard practice of the trade for measurement.**
- 5. In case of any dispute in measurement, decision of the garden Management shall be final & binding.**
- 6. All payments for logs need to be made in advance before their lifting.**
- 7. The entire operation should be completed within 45 days starting from the date of receiving the order.**

8. Applicants need to submit Earnest Money Deposit of Rs. 75000.00 in the form of Demand Draft payable to “Andrew Yule & Co. Ltd A/C Karballa Tea Estate” payable at Banarhat or Siliguri along with this application form. The EMD will be released to the successful candidate after the completion of the job. In case of unsuccessful bidders the Draft shall be returned to them. Offer without Earnest Money is liable to be rejected.

9. Penalty Clause: In case of delay in lifting the logs penalty clause shall be applicable @ the rate of Rs6000 per day of default which shall be recovered from the EMD already with the garden. However, no penalty shall be applicable in case of acts of god or riots/arson/Govt. regulations/Political Disturbances.

In case the Contractor abandons the project midway the entire EMD shall be forfeited.
