- Bidders should have average turnover of Rupees One Crores in the last three years. Audited accounts for the last three years have to be submitted with the Technical Bids.

The Bidder should be in a position to complete supply in 3 phases starting supply from first week of September, 2015 followed by October and November, 2015. The aforesaid delivery schedule is tentative and may vary in actual.
