GUIDELINES FOR VENDOR ENLISTMENT

1. Interested firms are required to submit the Vendor Enlistment application form as per format duly signed, stamped and submit the relevant documents to **Manager(Materials), Andrew Yule & Co Ltd, 5/346 Old Mahabalipuram Road, Perungudi, Chennai 600 096, Tamilnadu.**

The following documents are to be submitted along with application.

- a)** Registration certificate of MSEs from DIC (District Industries Centre) along with EM Part II clearly indicating category for which registration was made.
 - b)** List of major orders for similar items executed during last three years along with Performance Certificates from minimum 2 reputed power transformer manufacturer.
 - c)** Copies of registration certificates from other clients preferably from Reputed power transformer manufacturer/Govt institutions/PSUs.
 - d)** Catalogues / brochures of the product / services being applied for enlistment.
 - e)** Valid NSIC Certificate if registered with NSIC.
 - f)** Copies of CST/VAT,TIN, Central Excise registration, PAN ,Service Tax etc
 - g)** ISO Certificate/ any other Quality Certificates.
 - h)** Machinery details and Testing facilities.
 - i)** Turnover detail for the last three financial years.
- 2.** Vendors will be empanelled after necessary scrutiny by Andrew Yule. Mere submission of application for registration will not entitle the vendor for registration/enlistment.
- 3.** If required, a committee of Andrew Yule officials may visit your work site for scrutiny / assessment of the capabilities for manufacture and supply. You are required to extend all possible help to Andrew Yule officials during the visit and provide complete technical details/data wherever required.
- 4.** Applications incomplete in any respect, viz non-submission of any required document or information, or fee in requisite amount are liable for rejection.
- 5.** The MSEs already registered with Andrew Yule may forward the details and also inform whether the Enterprise is owned by SC/ST / Women /Others for updating our records with documentary evidence.
