2. Scope of Service:

A) **Placement of Vehicle:** - Transporters should always remain available round the clock over Telephone / Fax/E-mail for communication. Transporters are required to place vehicles within 24 hours of receipt of intimation received from consignor over Telephone / Fax/E-mail.

3. **Insurance:** Insurance shall be arranged by the company under its Open Marine Policy. Necessary Consignment Notes to be issued by the transporter.

4. **Validity of Contract:** The Contract will be valid from till 31st March, 2017. However the same may be extended for a further period of one month by mutual consent.
