1. Transformer tank cover conservator (TCC) should be manufactured as per our drawing and as per our material specification: SMF 113.

2. Painting:

For Price Bid I (Normal Painting)

a) All surfaces should be sand blasted / grit blasted to a finish of Sa 2.5 (ISO 8501-1:1988) before painting

External Surface: Epoxy Primer to a thickness of 50--70 microns (DFT) and enamel finish paint as per shade mentioned by us to a thickness of 25--35 microns (DFT)

Internal Surface: 1 Coat of Varnish (Dr. Becks Elmoluft 1A/FD) to a thickness of 30-40 microns (DFT)

For Price Bid II (Special Painting)

a) All surfaces should be grit blasted to a finish of Sa 2.5 (ISO 8501-1:1988) before painting

External Surface:

- a) Epoxy Primer to a thickness of 50--70 microns (DFT)
- b) All dent/grinding undulation should be filled with epoxy putty.
- c) Polyurethane finish paint as per shade mentioned by us to a thickness of 50--70 microns (DFT).

Internal Surface: 1 Coat of Varnish (Dr. Becks Elmoluft 1A/FD) to a thickness of 30-40 microns (DFT)

3) Material supplied will be inspected as per our inspection plan no. QAP 132 rev 1

4) Leak Test: Leak test to be conducted on TCC with water or air at a pressure of 9 psi as per our specification SMF 113.

5) All the covers/ dummy should be fixed on the tank while effecting delivery accompanied by detailed packing list.

6) Material test certificate should be submitted along with the supply of tank.
