- All steel posts to be grouted on cement concrete 1'-0" x 1'-0" x 2'-0" height on 3" brick soling as per drawing no. MU/RBT/17-18. Ratio of concrete would be 1:2:4.
- Painting on steel posts.

Chlorinated Rubber based paint two coats on one coat zinc chromate primer Make :- Berger/Asian, Colour : Smoke Gray for chlorinated Rubber, Yellow for Zinc chromate primer.

Sample of paint may be drawn at the estate for quality checking.

- Spring Steel wire 2.5 mm dialS4454 (Part-I): 2001 Grade: SM, Tensile Strength 1690-1890 Mpa, Hot dip galvanizing: 230 gms/mt<sup>2</sup>.
- Galvanizing Steel Strip 0.5 mm thickness IS 513: 1994, Grade DD, Zinc coating classification no. (2) Fe/Zn 12.5 um, IS1573: 1986.
- Steel Clip for fixing vertical and horizontal strands: 'C' clip made of 14SWG galvanized wire.
- Each coil/roll of RBT must be supplied along with quality assurance certificate of Directorate of Quality Assurance DGS&D, Govt. of India.

 Two individual strands of RBT wire should be jointed by 'J' clip at least 3 joints with galvanized steel 'J' clips.

The horizontal strands should be tensioned and fixed to the MS Angles by galvanized box clips and bolts with nuts which should be hammered and bend to prevent nut from being opened of the fixation of razor wire.


The support posts should be fixed to the main post by bolts and nuts which should be hammered and bend, so that nut can not be opened.

#### 1. Scope of work

#### 3. Requirement

#### 4. Delivery

The entire work is to be completed and handed over to the Estate Authority within shortest possible time.

The tenderers are requested to confirm the best possible delivery period in the following manner:

• For Murphulani T. E. – 4(four) weeks from the date of order.

#### 5. Liquidated Damage

In the event of failure on the part of the contractor to complete entire work against the order to our full satisfaction within the specified period of completion, we may recover from the contractor as liquidated damages, a sum equivalent to ½% of the contract price for each week or any part thereof default, where the delivery thereof will be accepted after expiry of the date stipulated for this purpose, but limited to a maximum of 10% contract value.

## 6. Force Majeure

Any delay or failure in the performance of either party hereto will not constitute default thereunder or give rise to any claim for damages, if any, to the extent such delays or failure of performance is caused by the occurrence such as acts of god or the public enemy, appropriation or confiscation of facilities by Govt. Authorities, acts of war, rebellion or sabotage, fires, explosions, riots and illegal strike.

#### 7. Risk Purchase

In case the contractor fails to executed the contract fully or partly, the purchaser shall have the right to execute the work through other agencies, as decided by the purchaser at the contractor's cost and risk after giving two weeks notice in writing.

#### 8. Price variation

The quoted price should remain firm during pendency of the contract.

#### 9. Terms of payment

a) 20% of contract value as advance against Bank Guarantee of equivalent amount to be valid till contractual delivery period.

b) 70% of contract value on completion of erecting at site duly certified by the Manager within 10 days from the date of submission of bill.

The above payment will be made in two part on pro-rata completion of erecting.

The 1<sup>st</sup> part will qualify only on completion of 50% job and balance on completion of entire work.

- c) Balance 10% of contract value within 30 days from the date of handing over the project to the Estate Authority against Bank Guarantee of equivalent amount valid till guarantee period / defect liability period.
- d) Statutory deduction will be made as per rules..

## 10. Guarantee/Defect Liability Period

12 months from the date of completion against defective materials and faulty workmanship.

#### 11. Purchaser's Liabilities

- a. Accommodation as may be available, for the erection team, during contractual delivery period, free of cost.
- b. One water tank for construction work.
- c. Transportation facilities for carrying materials from garden store to the site of work as and when required.
