3) Material supplied will be inspected as per our inspection plan no. QAP 132 rev 1

4) Leak Test: Leak test to be conducted on TCC with water or air at a pressure of 9 psi as per our specification SMF 113.

5) All the covers/ dummy should be fixed on the tank while effecting delivery accompanied by detailed packing list.

6) Material test certificate should be submitted along with the supply of tank.
