PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

Tiebreaking policy

In the event of more than one bidder become joint L1 then the tie will be broken as detailed below in the order of preference,

- I) Bidders previously engaged by AYCL (CO) for proving security services/manpower services and whose past performance was good
- II) Bidder who is MSMEs owned by SC/ST entrepreneur.
- III) Bidder having the maximum average turnover in the last 3 financial years ending 31.03.2020.
- IV) Random selection of L1 bidder by GeM portal.

If more than one bidders satisfies condition no 1, then condition no 2 will be used. If

more than one bidder satisfies condition no 2, then condition no 3 will be used, if the tie persist then condition no 4 will be used to break the tie.

Disclaimer
