Said Consultancy Firm will provide important inputs in manufacturing and field operations and also boost local sales by visiting vendors in Darjeeling, Siliguri and adjoining areas.

The scope of work for the Consultancy Firm will be as below:

- (a) Increase turnover of the assigned Tea Estate.
- (b) Implement various field development utilities (uprooting, replanting, block infilling & rejuvenation of aging tea bushes) for long term viability of the assigned Tea Estates.
- (c) Implement cost control mechanism and surveillance.
- (d) Introduce modern energy conservation and management practices.
- (e) Brand building through promotion and marketing of specialty and green tea in international market as well as widening domestic network of packet tea sales for further value addition.
- (f) Ensure healthy and cordial industrial relation at the Tea Estates.
- (g) Help the local Management/ Retail marketing team to develop the local market at Siliguri, Darjeeling & adjoining areas for retail sale.
- (h) Any other task and responsibilities as may be assigned by the management from time to time.
- (i) The Consultancy Firm has to visit the Tea Estate for a minimum of 3 days a week & the necessary pick up & drop from Siliguri will be provided by AYCL. Food & Lodging during the stay at garden will also be borne by AYCL.
- (j) A report has to be submitted to Manager of the assigned Garden with a copy to DGM(SCM) after every visit.

Eligibility Criteria: The Consultancy Firms must have experience of Darjeeling Tea with valid trade license.

**OTHER TERMS & CONDITIONS:**

**CONFIDENTIALITY OF DATA AND DOCUMENTS:**

- i) The Consultancy Firm engaged, shall not utilize or publish or disclose or part with, to a third party, any part of the data or statistics or proceedings or information collected for the purpose of his assignment or during the course of assignment for AYCL, without the express written consent of the Competent Authority.
- ii) The Consultancy Firm shall be bound to return/hand-over all the records of assignment to authorized officer/ authority before the expiry of the contract and before the final payment is released by AYCL.

**CONFLICT OF INTEREST:**

- a) The shortlisted Consultancy Firm engaged by AYCL shall in no case represent or give opinion or advise others in any matter which is averse to the interest of AYCL nor he will indulge in any activity outside the terms of contractual assignments.
- b) In case the services of Consultancy Firm are found in conflict with the interest of the Company, his/her services will be discontinued by terminating the contract without assigning any reason.

**TERMINATION OF ENGAGEMENT:**

- (a)AYCL may terminate the contract of engagement of the Consultancy Firm in following conditions:
    - i) Consultancy Firm is unable to address the assigned work;
    - ii) Quality of the work is not satisfaction of the concerned Trade/service divisions;
    - iii) The Consultancy Firm fails in timely achievement of the milestones as finally decided by the Management.
    - iv) Consultancy Firm is found lacking in honesty and integrity.
  - (b) AYCL reserves the right to terminate the engagement by serving 15 days written notice on the Consultancy Firm. Termination shall be affected on the day right after the completion of 15 days of delivery of such notice.
- (i) **Payment Terms:**Consultancy Firm will be paid on monthly basis based on the rate as mentioned in the Work Order placed on him/agency.
