Scope:

AYCL is in the process of selection of suitable sub contractor who will manufacture distribution and power transformer up to 16 MVA, 110/132 KV for AYCL Chennai operation. The scope of work in this EOI comprises of design, manufacture, testing and supply of the above range of transformers.

Qualification Requirements:

1. Should have experience in design, manufacture, testing and supply of the above range of transformers including after sales service activities.
2. The proposed partner shall have supplied 10 Nos. of oil filled transformers of assorted range & type up to 16 MVA, 110/132 KV class type within last 5 years (2012-13 to 2016-17)
3. Should have minimum 2 nos of transformer of rating 5 MVA or above in service for minimum 2 years. Bidders are requested to submit the performance certificate for their highest rating of transformer, since it will be a deciding factor for categorizing the bidders.
4. Should be ready to demonstrate the capability of design & manufacture strength by conducting type test and short circuit test as per the contractual requirement.
5. Shall have a minimum turnover of Rs. 15 crores in transformer manufacturing in the last three financial years. (2014-15, 2015-16 & 2016-17)

Selection Criteria:

1. Bidders, who have met all the above qualifying requirements, will be eligible for selection. Based on the documents submitted they will be classified as follow,
 - a) Subcontracting of transformer up to 5 MVA
 - b) Subcontracting of transformer up to 10 MVA
 - c) Subcontracting of transformer up to 16 MVA
2. Inspection of facilities by AYCL representative.
3. Acceptance to enter into a MOU with AYCL to provide the above supply & services to AYCL on mutually agreed commercial terms on back to back guarantee basis.
