- ❖ **DEFECTS LIABILITIES PERIOD:** 12 months from the date of issue of completion certificate. After completion of work, a checklist would be prepared by Inspection team and the same will be attended by the contractor within 15 days and a completion certificate would be issued.
- ❖ **L/D Clause:** @ ½ % per week subject to a maximum of 5% of the order value.
- ❖ **Validity of Offer:** The offer should remain valid for at least 60 days.
- ❖ **Risk Purchase:** For delay in execution, we reserve the right to procure the same through some other agency(s) which shall be deemed fit and the additional cost if any (incidental / consequential) shall be deducted from your payment.
- ❖ **Arbitration :** All disputes relating to this order or relating to the price of the goods supplied there under or otherwise arising there from between the seller and buyer shall be subject to and referred to the court of competent jurisdiction situated within the limits of the city Kolkata neither the seller nor the buyer shall take or adopt any legal proceedings to enforce any claim against the order relating to this order or arising there from in any court other than the court of competent jurisdiction within the limits of the city of Kolkata.
