1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

### 3. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

# **1.** Scope of work:

i. Supply as per specification, FOR garden on "door delivery" basis ex-Siligu ri. Mim Tea Estate will be arranged collection from the Siliguri dump of the supplier.

# 2. Specification:

<u>Dust Coal</u>: Coal conforming to grade "B" of non-coking coal as per No tification No.291 of Ministry of Energy in terms of Ash Content, Moist ure content, Volatile matter, Fixed carbon and UHV range 5600 K. Ca I/Kg to 6199 K. Cal/kg.

We will be accepting Coal with UHV minimum 4940 K.Cal/Kg. confor ming to Grade "C" below which the supplies will be rejected. The Coa I should not be wet.

# 3. Testing:

From each consignment / truck, two samples will be drawn with proper identif ication mark.

One sample will be sent for testing and other will be retained at the estate lev el for future reference, if any.

- i. For every drop of UHV of 100 K. Cal/Kg. below 5600 K. Cal/Kg., deduction of Rs.200/- per Ton will be made from the agreed price. The Test Report will be final and binding on both sides.
- ii. For every rise of UHV of 100 K. Cal/Kg above 6199 K. Cal/Kg, bonus of Rs.75/- per Ton will be extended over the agreed price. The Test Report will be final and binding on both sides.

# 4. Requirement:

The entire supplies are required to be made within 4 months from the date of order. The estimated requirement during this period are as follows:

**5. Price Variation:** The rate should remain firm during pendency of the contr act.

# 6. Delivery:

- Minimum 30% of the order quantum within next one month/2<sup>nd</sup> month.

- **7. Mode of Transportation:** Supply from source to be done under single chal lan with no transshipment enroute.
- **8. Risk Purchase:** In the event of failure on the part of the supplier to comple te the supply within agreed delivery schedule, the purchaser reserves the rig ht to arrange balance material from alternative source at the cost and risk of the supplier.

# 9. Other General Terms & Conditions:

- i. Decision for awarding contract / job is vested with the Management so as to reject, split / fragment.
- ii. To ensure smooth supply throughout the contractual period, the total qu antity of order for the group will be fragmented garden-wise & further am ong L1/L2/L3 etc. at L1 rate. However, preference towards higher allocatio n will be given to the lowest bidder and so on.

However, for new entrant / untested vendor, on being qualified, will only b e considered for Trail Order. Past Vendors having received major quality c omplaints for supply of inferior quality Coal may not be considered for fut ure supplies.

- iii. Location-wise incomplete "Quotation / Offer" is liable to be rejected.
- iv. The offer must be valid for our acceptance for 30 days from the date of o nline bid

# Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
